

AGREEMENT BETWEEN ALASKA BAR ASSOCIATION

AND

THE UNITED STATES DISTRICT COURT FOR THE DISTRICT OF ALASKA

The Alaska Bar Association and the United States District Court for the District of Alaska share the concern that attorneys practicing before the federal courts in Alaska comply with the Code of Professional Responsibility. Accordingly, the Alaska Bar Association and the United States District Court for the District of Alaska reach the following agreement:

1. The Alaska Bar Association will advise the Chief Judge of the District Court of any public discipline imposed against an Alaska attorney by either the Association or the Alaska Supreme Court;

2. The Chief Judge of the District Court will review the order imposing discipline upon an attorney to determine whether reciprocal discipline should be imposed by the District Court;

3. The Alaska Bar Association will investigate complaints of unethical conduct brought to its attention by judicial officers of the District Court; such investigations will be captioned Alaska Bar Association v. Respondent Attorney;

4. The District Court will cooperate with the Alaska Bar Association in its investigation of attorneys practicing before the District Court;

5. The District Court will provide copies of file documents in its possession without charge to the Alaska Bar


Association; the Alaska Bar Association will provide personnel assistance in making the copies upon the District Court's request;

6. The District Court will make cassette copies of hearing tapes without charge to the Alaska Bar Association; the Alaska Bar Association will provide blank cassette tapes for this purpose;

7. Representatives of the Alaska Bar Association and the District Court will meet as needed to discuss mutual areas of concern regarding disciplinary matters.
